In July, HBEP Director Susan Thompson was in Ireland to attend the Joint European (AESOP) and American (ACSP) Planning Schools Congress 'Planning for Resilient Cities and Regions'. Held at University College Dublin, the Congress had over 1,000 participants from more than 50 countries. A mammoth program of papers across 16 Tracks encompassed the breadth and depth of contemporary planning research and practice. It was exciting to hear many papers on healthy planning. Susan presented a paper showcasing the work of the HBEP. # Planning and Building Healthy Communities Project

Since 2011, the HBEP has worked on an ARC Linkage Grant 'Planning and Building Healthy Communities' with partners UrbanGrowth NSW (formerly Landcom), the National Heart Foundation, and the South Western Sydney Local Health District. The aim of the research is to understand how our four case study sites – Airds Bradbury, Rouse Hill, Victoria Park and Renwick – can make healthy everyday living a reality. The project has involved developing a Healthy Neighbourhood Audit Instrument to map each site in detail, and record observations about how people use different spaces. You can read more about the Audit Instrument here. We also used a Market Basket Survey Instrument to record healthy food availability, quality and costs in each locality, as well as assessing produce at farmers' markets. We are now interviewing residents about how their neighbourhoods support or make a healthy lifestyle difficult. The focus is on being physically active, interacting with others and accessing healthy food. We are currently recruiting interviewees, so if you are over 18 years and live in one of the four neighbourhoods, register your interest here or contact HBEP Research Officer Emily Mitchell: e.m.mitchell@unsw.edu.au

On 11 September HBEP Research Associate Jennifer Kent presented a seminar on her PhD research entitled Secured by Automobility, why does the private car continue to dominate transport practices? The seminar attracted over 30 attendees – researchers, students, policy makers and practitioners from across UNSW, Transport for NSW, local government and cycling advocacy groups. A number of interesting issues were raised in discussion, including questions from Transport for NSW as to how the research findings can be incorporated into its data collection processes.
