### A Word from the Director

#### Welcome to our first newsletter for 2013. It has already been a big year for the HBEP!

On Tuesday the 16th of April, the NSW Premier and Minister for Planning released the White Paper for the ongoing review of the NSW planning system. The draft legislation contained in the White Paper includes the promotion of health as one of eight principle objectives. This is highly significant. The NSW draft Act represents the first time a state/territory Planning Act has included the promotion of improved health as one of its key objectives. The HBEP has advocated strongly for the inclusion of health and wellbeing as an objective of the new Planning Act, and will continue to do so through the upcoming consultation period. Keep reading below for further details of the health objective and information on how you can make a submission.

We have now completed three out of the series of ten 'Planning for Health' workshops that we are delivering across the state. Participants at the workshops provided valuable feedback, and this has been incorporated into the planning and preparation for future workshops. You can find out more about these workshops below.

I'm delighted to announce that Jennifer Kent has now officially been appointed as the HBEP's new Research Associate. # The CRC for Low Carbon Living

On 12 December, the Cooperative Research Centre (CRC) for Low Carbon Living was launched at UNSW. You can find out more about the CRC here. HBEP Director Susan Thompson is the Research Leader for one of three Program areas in the CRC – titled *Engaged Communities*. As Research Leader, she acts as a liaison between researchers and industry partners, meets with prospective PhD students, and is involved in the development of specific CRC research proposals. Most recently, along with HBEP Strategic Consultant Tony Capon, Susan started work on a proposal for a key deliverable of the CRC – a health and productivity co-benefits calculator. Subject to approval by the CRC board, this project will commence later in 2013.

# Planning for Health Workshops

The HBEP is currently presenting a series of day long workshops on the NSW Planning System across NSW. Designed to enable health professionals and related stakeholders to better engage with a range of planning proposals, the workshops are being presented by HBEP Director Susan Thompson and HBEP partner, Dr. Danny Wiggins throughout 2013. Workshops have been held in Port Macquarie (December 2012), Belmore (February) and Newcastle (April). Workshops will shortly be delivered in Shellharbour (21st May) and Penrith (23rd May). # **NSW Planning System Review**

As previously reported, the HBEP has made several submissions to the NSW Government as it undertakes the first comprehensive review of the State's Planning System in over 30 years. All HBEP submissions on the Planning System Review (made in 2011 and 2012) can be accessed here.

On the recent release of the review's White Paper, we were very encouraged to see that the draft NSW Planning Act for comment includes the promotion of health as one of eight objectives. The specific objective addresses 'health, safety and amenity in the planning, design, construction and performance of individual buildings and the built environment'.

Comments on the White Paper, including the draft legislation, are now invited from stakeholders and the public. Individuals and groups can make submissions online by either uploading a prepared attachment or using the online feedback tool to submit comments on specific sections or chapters of the White Paper. You can also join the discussion by participating in online discussion forums or attending one of the briefings, feedback sessions and meetings being held across NSW.
