Stakeholder Workshop

The HBEP held a Stakeholder Workshop on 16th February which involved participants from a wide range of organisations including NSW Health, PCAL, RTA, Landcom and Stockland. The aim of the workshop was to identify policy gaps in healthy built environments. The findings will feed into the HBEP Research Strategy to be released in 2011.

HBEP Literature Review

The HBEP's Literature Review which examines the link between health and the built environment has been completed. The Review, and a series of fact sheets presenting its findings, will be disseminated in 2011. National Urban Policy Discussion Paper

The Commonwealth Government's Major Cities Unit released a discussion paper entitled *Our Cities - Building a productive, sustainable and liveable future* in December 2010. The purpose of this paper was to frame the Government's policy approach to 'cities' as the basis for a National Urban Policy to be released later in 2011. It was open for public comment until 1st March 2011. The HBEP made a submission to bring attention to the role of health and wellbeing in national urban policy.
